Private herd number may be branded on hide, written on ear tag, tattooed in ear or recorded electronically on RFID tag with accompanying documentation and photo verification of calf at dam’s side.
- Cattle are to be presented for inspection only (and not to be worked otherwise during inspection without prior arrangements).
- Owner is to provide someone capable of pulling DNA samples.
